# CONTEXT

Samos is geographically located as the closest Greek island to the Turkish coast, and therefore welcomes a large number of people seeking international protection every year. Although many report surviving multiple pushbacks, over 7500 asylum seekers arrived in Samos in 2023. These applicants do not have access to state-provided legal aid before their asylum interview.

Since 2021, asylum seekers reside in a "Closed and Controlled Access Centre", a detention-like facility that is a first of a long series to be built in Greece and Europe as a deterrent measure for arrivals.

The Samos Legal Centre, opened in 2019 by ASF France, aim to contribute to guaranteering the right to seek asylum and to protect the fundamental rights of asylum seekers. In order to do so, the team on the ground welcome asylum seekers on a daily basis to provide free legal aid. seekers.
