# Samos Legal Centre : a project to guarantee the rights of asylum seekers in the face of a failing migration system

"The migration situation in Europe, particularly in Greece, continues to be marked by dramatic conditions. On the island of Samos, almost 10,000 people disembarked in 2024, and the reception centre for registering asylum seekers, the Closed Control Centre, was at its most alarmingly Access overcrowded, with 132% of its capacity occupied. This model, the only one of its kind in Europe, which is supposed to facilitate the procedure, is actually worsening the living conditions of people seeking protection. In this climate, the Samos Legal Centre project provides a response by offering full legal support for asylum seekers at every stage of the procedure, from registration to a possible appeal against a rejection decision, including support for family reunification, for example.

In Greece, the challenges are many: inhumane reception conditions, a lack of interpreters that complicates and slows down the procedure, repeated human rights violations, and practices such as de facto detention. It is against this backdrop that the Samos Legal Centre and a number of other NGOs are working together to provide free and independent legal support to displaced people. Our work focuses on one of the most delicate stages of the procedure: the asylum interview, which is based solely on an oral account, without any written documents, making this exchange even more decisive for the applicants.

But solidarity in the face of this situation requires much more. On 3 December, ASF France and four other non-profit organisations in Greece (Mobile Info Team, Equal Legal Aid, Human Rights Legal Project, and Legal Centre Lesvos) launched the #JointLegalAidFundraising campaign. This initiative aims to ensure access to legal aid and justice for displaced people in Europe, particularly in the face of rising xenophobic policies and anti-migrant rhetoric that make access to rights even more complex.

The number of arrivals and the worsening living conditions of refugees call for immediate action. Forced expulsions (pushbacks) and unjustified arrests, often violent, have intensified. Once in Europe, people fleeing war and persecution face overcrowded camps with no access to essential services. Against this backdrop, our joint fundraising aims to ensure that these vulnerable people can defend their rights and access fair justice.

To date, over £2,625 (approx. €3,132) has been raised for this cause, and the aim is to reach £15,000 (approx. €17,900) to support our actions and those of other organisations, strengthen our legal services and offer every asylum seeker the chance to defend themselves. Every donation counts, because it amplifies the voices of those whom the system tries to silence.

### FRANÇOIS CANTIER ON THE HUMAN RIGHTS PRIZE OF THE FRENCH REPUBLIC, SPECIAL MENTION, RECEIVED BY ASF FRANCE AND SEMA UKRAINE

On 10 December 2024, Avocats Sans Frontières France received a Human Rights Prize, Special Mention from the French Republic.

This is the first time that a lawyers' organisation has received such a distinction in France.

ASF France is sharing this prize with a Ukrainian NGO, SEMA, with which it has set up a project to defend Ukrainian women who are victims of sexual violence. SEMA provides medical and psychological care and ASF France assists with their legal and judicial defence in proceedings against their aggressors.

The award was presented to us on 10 December 2024 in the presence of the Minister of Justice, the President of the National Advisory Council on Human Rights and the United Nations High Commissioner for Human Rights.

This recognition also rewards our 27 years of efforts to achieve our raison d'être: to bring the protection of the law to the most vulnerable. We hope that all those involved - public institutions, private companies, justice-loving citizens and legal professionals - will provide us with the financial support we need to continue our work.
