



TO TAKE ACTION IN THE NAME OF JUSTICE AND FREEDOM

As such, we will ensure as volunteers the defence of any individual whose fundamental rights are being threatened and who do not have access to a free and independent defence. Our mission consists in bringing support and assistance to the lawyers and Human Rights activists who are jeopardised because of their stands and professional activities.

TO CONTRIBUTE TO THE REINFORCEMENT OF THE RULE OF LAW

We intervene anywhere around the world as long as it is necessary to support the Rule of Law, the Judicial system or the right to a fair trial. We dedicate ourselves to strengthen local activists and legal bodies by responding to their needs and working alongside with them.

OUR STRATEGY

• TO DEFEND CITIZENS AND HUMAN RIGHTS DEFENDERS

ASF France ensures under pressure the defence of any individual whose fundamental rights are threatened and who cannot afford to hire an independent lawyer. ASF France also intervenes when a lawyer is subject to intimidations in the line of his duties: threats, imprisonment and assassination. Hence, beyond being a lawyer, it is the citizen himself that is deprived from defence and therefore, justice.

TO PROMOTE ACCESS TO JUSTICE

Promoting access to justice is one of our priorities, that is why we have a hand in the implementation of legal aid system and legal structures. From this perspective, we contribute to protect the most vulnerable people when their rights are nonexistent or being denied, notably by making available legal counsel and services — settled of mobile legal consultations, reinforcing the judicial systems, sensitising citizens and legal activists and so on.

TO DEVELOP THE AUTONOMY OF THE LOCAL STAKEHOLDERS

In order to reinforce effectively the capacities of the local stakeholders, ASF France will provide an initial and continuing training adapted to the needs and difficulties encountered.



RESULTS

- Secure living conditions are preserved for the LGBT community and their defenders, allowing them to enjoy their rights and improve their quality of life
- The visibility and the cooperation between LGBTI's stakeholders in Cameroon are reinforced
- The dialogue between the Cameroonian authorities, the LGBTI's activists and the international and local organisations defending LGBTI's rights has improved
- State and non-state actors have been sensitised on the existence of regional procedures put in place by the African Commission on Human and Peoples' Rights (ACHPR) for the promotion and protection of Human Rights. They are able to carry on the work by popularising and establishing these procedures in the region.



TESTIMONIES

I was a victim. My human rights have been violated from 1992 to 1998 while I was still a child. My uncle has been murdered by the « daugaris of lamido » in 1992 in my father's house. Following this incident, my father disappeared from the family home, leaving his three children on their own. I was among the 3. When I finally met up with my father in 2001, he explained that he had been forced to leave, otherwise he would have also been killed. From this experience, I have become an activist.

- To make local NGOs aware of their sphere of intervention, their limits and their rights
- To sensitise the general public as well as the local government entities on the defence of human rights
- To ensure a collaboration between local human rights defenders NGOs for a better intervention strategy
- To train NGOs and local associations on the protection of vulnerable groups

ACTIVITIES IN 2016

- Installation and launch of the project: meetings and working sessions with the local team and the partners
- ♦ 2 workshops providing information and diffusing the Law No. 2014-388 of the 20th of June, 2014 on the protection and promotion of the Human Rights Defenders took place in Guiglo and Bouaké, involving 64 organisations, NGOS, journalists and LGBTI defenders
- A launch conference was organised, gathering 70 people
- An interview was diffused by a local radio station, introducing the project and informing the public

RESULTS

- Civil organisations have a better knowledge of the mechanisms of protection provided by the 2014 Law. Therefore, they are able to build an efficient protection of the Human Rights Defenders.
- Local authorities are sensitised on the fundamental role of Human Rights Defenders and have reinforced their capacities to ensure their protection and those of the vulnerable groups

ACTIVITIES IN 2016

- Free legal aid was provided to 50 people who were victims of acts of torture or ill-treatment in the states of Kaduna et Enugu
- 2 training sessions on the principles of the CAT for judicial agents: 23 participants in Kaduna and 23 participants in Enuqu
- 2 training sessions for legal and medical professionals: 17 participants in Kaduna, 17 participants in Enugu
- Setting up of a network of professionals: 27 participants in Kaduna and 17 participants in Enugu
- Awareness raising: 2 radio broadcasts organised in the two states

RESULTS

- Persons who were victims of torture had access to a lawyer
- Stakeholders were trained and sensitised to the principles of the CAT and the collection of evidence
- The population was sensitised and informed of their rights
- The authorities were sensitised to the respect for the CAT principles

TESTIMONIES



"I was imprisoned more than 6 years ago, in October 2011. I arrived with 5 bullet wounds inflicted by the police. I desperately needed help to get out of prison to obtain medical assistance. One day in 2015, one of the lawyers of ASF France visited me in prison and presented this international organisation to me. It helps prisoners who are unable to pay for a lawyer to represent them in court. Today, I am still waiting for my trial, but thanks to the actions of ASF France the judge has awarded me 1 million Nairas in damages for the acts of torture committed by the police."

"I arrived in prison in 2012 with a bullet wound in my lower back. A doctor at the « University of Nigeria Teaching Hospital » (UNTH) put in place a splint, but I didn't have the means to pay for any further treatment outside of prison. The judge awarded me 1.5 million Nairas in damages for the acts of torture that I suffered at the hands of the police but not my release on bail because of another case before the court. ASF France helped me and supplied me with a lawyer to defend me. ASF France gave me hope - I am grateful and I thank them for it."

Mission in Abéché

OBJECTIVES

The project aimed to:

- ◆ Contribute to the strengthening of the rule of law and the judicial system in Chad
- ◆ Contribute to a better treatment of women and detained minors
- ◆ Contribute to reducing violence against women and minors and to defend their rights

ACTIVITIES IN 2016

- ◆ 72 detention consultations enabling 135 women and minors to have access to a lawyer
- ◆ 53 legal advice and psychological support services provided assistance to 112 women and minors victims of violence
- ♦ 44 cases were taken on by lawyers working on the project as part of the legal aid programme
- ♦ 3 training sessions for 68 legal professionals, prison officers and law enforcement officers
- ♦ 4 educational talks, 5 radio broadcasts and 2 films helped to raise awareness about the rights of women and minors among many Chadians
- ♦ 3 panel discussions took place with 32 judicial, administrative and civilian authorities in order to develop strategies to rectify failings in the women and children's human rights protection system

RESULTS

- ◆ The capacities of all actors of the "penal chain" are reinforced. They are more aware of the role they play in the protection of women and minors' rights at each step of legal proceedings
- A synergy of action is created between actors in the penal chain and the relevant authorities in order to improve practices and the protection of women and minors
- Legal procedures aimed at ensuring compliance with the minimum rules in relation to the detention of vulnerable people are effectively initiated and followed

TESTIMONY

The Assistance and Legal Aid Programme for Women and Children that we are currently implementing in Chad is an opportunity for ASFF to achieve its goals: we have already aroused the interest of 68 justice and human rights professionals, 31 administrative authorities working to protect rights, over 3 million radio listeners and 200 influential community members from across Ndiaména. Abéché and Koumra, We have also provide



community members from across Ndjaména, Abéché and Koumra. We have also provided information to 132 detainees in these three towns pertaining to their human rights. 30 of the detainees are already receiving legal aid from PADEF lawyers to ensure that their right to a fair trial is upheld. My desire to take part in the strengthening of peace and justice, whatever the milieu, is the principal driving force behind my participation in programmes promoting and protecting human rights in Africa. I see myself as a citizen of the world and I am therefore alert to questions surrounding fair justice and human dignity without discrimination, in particular for those without a voice.

OUTLOOKS

- In the three towns targeted by the project, legal consultations will take place each month and medical, psychological and legal consultations will be offered to women and minors victims of violence
- Roughly 130 cases of women and children deprived of liberty/or victims of violence have been taken on without charge by lawyers working on the project as part of the legal aid programme
- ♦ Radio broadcasts, film screenings, plays and educational talks to raise awareness about women and minor's rights amongst the population and Chadian authorities
- ♦ 5 training sessions for instructors, followed by training sessions for legal professionals, prison officers and law enforcement officers will be organised, 5 panel discussions bringing together 60 authorities will be organised in order to develop a Charter of Good Practices
- ♦ 3 Chadian non-governmental organisations will be supported and subsidised in order to create local initiatives for eradicating violence against women and children in the targeted towns

OBJECTIVES

This project aimed to:

- Strengthen the rule of law and promote access to law and justice for the population of the province of Battambang, particularly those who are most disadvantaged
- Improve the defence of defendants who have been denied the right to legal counsel in criminal cases, mostly due to a lack of resources

ACTIVITIES IN 2016

- ◆ Free legal support services within the Tribunal and legal advice has been offered to people in need. The legal support services are available 4 mornings a week.
- ◆ Taking on cases relating to criminal matters, each lawyer defended between 10 and 12 criminal cases a month
- ♦ Over 100 cases were taken on by lawyers working on the project
- ◆ Over 180 people have benefited from the project



RESULTS

- Defendants have benefited from free legal counsel
- The defence of defendants is guaranteed
- ◆ The government and the Ministry of Justice have been made aware of the need to address the current shortcomings in terms of access to law and legal aid

TESTIMONY

This project has enabled us to hire two Khmer Cambodian lawyers in charge of the defence of criminal cases; they each take on between 10 and 12 cases a month. They also perform legal support services through which they give legal advice to the local population. As part of this activity, we also organise workshops directly into the communities, raising awareness about legal matters and responding to the questions of those who are unable to attend the legal support services. We are in direct contact with the local population and local NGOs, with whom we are trying to develop partnerships in order to conduct awareness-raising workshops directly with their beneficiaries. That was the case with the organisation "Phare Ponleu Selpak".



OBJECTIVES

This project aimed to:

- Provide legal advice to organisations based in Calais on both asylum rights and the rights that migrants possess due to their presence on national territory
- Contribute to providing better care for migrants and as such contribute to ensuring that their fundamental human rights are respected

ACTIVITIES IN 2016

- ◆ Volunteers working for organisations based in Calais and in the surrounding area were provided with legal information
- Legal consultations to aid migrants took place within organisations in Calais

RESULTS

- Migrants in Calais received useful legal information and advice in order to ensure that their rights were respected

 Contribute to respecting the fundamental rights of refugees by ensuring that, throughout the migratory process, there is a specific protection in place for women and children

ACTIVITIES IN 2016

Joint intervention in Greece in partnership with Doctors of the World (MDM)

- Creation of a steering committee made up of representatives from ASF France and MDM
- Three lawyers (members of ASF France) joined MDM teams and its international network to work in refugee camps in Greece
- Collecting testimonies from migrants on these issues

TESTIMONY

In July 2016, we were able to observe operating refugee camps in Greece; we have also been able to meet with several association leaders and institutional bodies. Our visit took place several weeks after the signature of an agreement on the 18th March 2016 between the European Union



and Turkey, introducing nothing less than an intolerable system of migrant "bartering", in complete contravention of the provisions of the Geneva Convention.

We have seen the immediate consequences of this agreement and we felt ashamed. As a result, we decided to take action, and to make use of our abilities and knowledge of the law for the benefit of our brothers in the camps. Doubtless we also wanted to pay service to the European ideal, that of a welcoming land, a place of fraternity and solidarity. Our determination to defend, time and again, peoples' human rights wherever they are jeopardized has only been increased.

ACHIEVEMENTS TO DATE

21 national associations currently belong to the ASF Network :

Brazil, Benin, Cameroon, the Central African Republic, Colombia, Comoros, Congo, the Democratic Republic of Congo, France, Guinea, Italy, Ivory Coast, Mali, Mauritania, the Netherlands, Peru, Senegal, Sweden, Switzerland, Togo and Tunisia.

In June 2016, ASF France and ASF Mali organised and led an exploratory mission in the North of Mali in order to design and implement **a project** improving the skills of the judges of the Court of Appeal in Mopti. The **programme**, funded by the Ministry of Foreign Affairs and International Development (MAEDI), **began** in April 2017.

31st ANNUAL CONFER-ENCE of the CIB in Yaoundé

A meeting of the ASF Network was held at the end of the Annual Meeting of the International Conference of Francophone Bars that occurred in Yaoundé (Cameroon) from the 7th to the 9th of December 2016.

This large annual meeting is a major event for both the profession and lawyers from the civil law tradition. Several presidents of the Bar from the francophone world participate in this event as well as numerous delegations of international and national lawyers.

The theme of this 31st Conference was "The rule of law faced with new security challenges, myth or reality", reflecting the role played by lawyers in defending the rule of law and preserving democratic gains.

« Strengthening and development of Lawyers Without Borders' (ASF) organisations »

Established in 2009, the Lawyers Without Borders (ASF) Network aims to develop and strengthen ASF organisations by sharing tools and experiences across the network, coordinating actions and improving transparency for the benefit of the most vulnerable members of society.



OUTLOOKS IN 2017

- ◆ Continue to support lawyers and human rights advocates
- Develop projects that are in partnership
- Increase the capabilities of national organisations



The president of ASF, Mr Cantier, took part in the conference and spoke on the theme of society and whistleblowers under the protection of the rule of law.

ASF Benin, ASF Cameroun, ASF Congo, ASF France and ASF Togo were present at the meeting in order to provide updates on the activities of each organisation and to allude to the Network's future projects.

ASF FRANCE & THE FRENCH-SPEAKING WORLD





The French-speaking world is first and foremost a group of men and women who share a common language: French. Since the early 20th century, French-speakers have been aware of the existence of such a shared linguistic space, enabling exchanges and opportunities for mutual enrichment. A multitude of organisations and groups have been created, in order to bring the French-speaking world alive every day.

ACHIEVEMENTS TO DATE

- Involvement in the work on relations between the French-speaking civil society and the International Organisation of the French-speaking world (OIF)
- Participation in the 10th conference of French-speaking international NGOs, that occurred from the 2nd to the 4th of November 2016 in Antananarivo, Madagascar. ASF France organised and hosted a round table discussion on "French-speaking civil society facing the challenges of the migrant crisis"
- Participation in the 16th French-speaking world summit, where Mr Cantier headed the Conference of international NGOs during the Summit of the Heads of State of the French-speaking world, the Permanent Council of the French-Speaking world and at the Ministerial Conference of the French-speaking world

The International Organisation of the French-Speaking World (OIF) hopes that the civil society and its organisations will become partners of the French-speaking world.

In this light, it has recognised a number of international nongovernmental organisations (NGOs), including ASF France. They hold a Consultative Status within the OIF.

These organisations are split into 4 groups:

- A. French language, linguistic and cultural diversity
- B. Peace, democracy and human rights
- C. Education, training, higher education and research
- D. Economic cooperation, sustainable development and solidarity. Twenty-four international NGOs, including ASF France, took part in the project "Peace, Democracy and Human Rights". ASF France was elected as chair of the NGOs for this project.

OUTLOOKS IN 2017

- Intensify the relations between the civil societies of the different francophone countries
- Strive for the development of projects in partnership, leading to the effective improvement of the rule of law



TRAINING PROGRAMMES

In addition to its status as an international solidarity organisation, ASF France has been recognised as a training organisation by the Regional Management of business, competition, consumerism, work and employment.

ASF France is firmly convinced that training is an indispensable tool in order to improve the capabilities of practitioners.

The organisation leads two types of training activities:

- Aimed at local legal practitioners: these activities play a key role in the programmes that occur in each individual country. They lead to the empowerment of local participants
- Aimed at practitioners participating in ASF France projects: all ASF France participants follow a preparatory course for their participation which includes a section on methodology and a technical section on diverse legal topics

ASF France training sessions are recognised under the Individual Training Right (DIF), are certified by the National Council of Bars and can be funded by the Fund for the Interprofessional Training of Independent Professionals (FIFPL) for lawyers practicing in France.

ASF FRANCE & THE CDAD

The Departmental Councils promoting Access to Law (CDAD) offered citizens the opportunity to meet with lawyers in order to learn about their rights and responsibilities and to receive guidance for any initiatives they may undertake. The lawyers who participated gave their time in order to donate a proportion or all of the payments received for CDAD consultations to ASF France.

Joint action that enables access to the law

The aim is to facilitate access to Law.

The idea is to pool resources so that every free consultation given in France allows ASF France to extend the scope of their actions in aid of the most vulnerable members of society elsewhere in the world. This is made possible by joint action of the Bar, the CDAD and ASF France enabling our organisation to promote international solidarity.

Action with ASF France

The idea is that, over a given period of time — ideally a week — lawyers giving out free legal consultation sessions are encouraged to contribute the remuneration usually paid to them by the CDAD to ASF France. This one-off action is open to all volunteer lawyers, whether or not they are registered on the list of lawyers who work regularly with the CDAD.

Establishing such an event is the result of an agreement between the Bar, the CDAD and ASF France.

The event generally finishes with a ceremony during which the money raised is handed over, which enables us to gather together and to thank all of the parties taking part in the initiative.

From the 19th to the 24th of September 2016, lawyers at the Bar of Toulouse organised a week of free legal consultations with the assistance of the CDAD in Haute-Garonne in order to help vulnerable members of French society and elsewhere in the world.

At the closing ceremony for this initiative, ASF France, surrounded by its partners and benefactors, **was presented with a cheque for 9932 euros**.



Mr François Cantier, the founder of ASF France, was presented with the funds raised by the Toulouse lawyers by Mr Marc Pouyssegur, President of the Toulouse High Court and the Haute-Garonne CDAD, and by Ms Anne Fauré, President of the Toulouse Bar Association.
