

Thanks to the work led by François Cantier, President of the organization, since its creation up to october 2011, and to the dynamism of its members, Lawyers without Borders France has aquired from these long years now the confidence of its most vulnerable people of which it defends, but also the estime of all categories of partners in the reinforcement domain of the rule of law and in the promotion of an equal justice.

Accepting charge as President in October 2011, I measured up to the responsibility that will be mine to continue to encourage our engangement of service to our values. Thanks to the involvement of all and the confidence gained, ASF France continues to develop its action wherever the defense no longer has a voice.

Our major areas of intervention reside in those of our charter: access to law and to justice for vulnerable people, the protection and free exercise of the legal profession to benefit the most vulnerable, the urgent defense for its defenders of human rights and of its victims of the most serious injustices, the reinforcement of the capacity and empowerment of the local actors of justice.

The year opens with a new project in Tunisia, the technical assistance for the strengthening of the instutional capacities of the Higher Institute of Legal Profession (ISPA). This project translates to an outcome of support brought to our fellow Tunisian victims of the repression under the old regime. It can now contribute to, through the strengthening of the legal profession of this country, the revival of the rule of law.

NIGERIA: The Fight against Torture

ASF France takes action for 10 years in Nigeria, following its intervention to support the defense of Amina Lawal, a young woman sentenced to stoning by a Sharia court for having a child out of wedlock.

Today:

- Despite the signature in 2011 of the United Nations Convention against Torture, torture is commonly used during police custody to obtain confessions.
- The access to the law and to justice is very difficult for vulnerable persons.



PROMOTION OF THE PRINCIPLES OF THE UNITED NATIONS CONVENTION AGAINST TORTURE (PROCAT): MARCH 2009 – June 2012

To contribute, thanks to the mobilization of Nigerian juridical actors and to the information of the population, the reduction of acts of torture and ill-treatment during the legal proceedings.

Result in 2011:

- 274 cases of detainees, victims of torture, followed
 - 16 cases of recognition of the violation of human rights by the courts
 - 8 cases leading to a right to a compensation
 - 47 cases of release on bail
 - 25 cases of final release
- 188 judiciary actors formed in 4 states (Kaduna, Kano, Lagos, Plateau)
- 60 community leaders and members of civil society were trained
- · Awareness in the fight against torture and to legal laid

In 2012...

- ♦ Continued monitoring of identified cases, and identification of new cases; implementation of legal proceedings against perpetrators of orture to obtain a conviction.
- ♦ Formation of an additional one hundred juridical players in the states targeted in the project, and implementation of new roundtables to bring together key players of the court of each state to exchange good practices.
- ♦ **Development of awareness**: posters, radio spots and awareness workshops.

NIGERIA: The Fight against Death Penalty

Today:

- Between 550 and 700 people are in death row awaiting their execution.
- Despite a de factor moratorium, many people are still condemned to death, and executions have taken place underground.

STRENGTHNENING OF THE ROLE OF LAWYERS IN THE FIGHT AGAINST THE DEATH PENALTY (SAVING LIVES: SALI): JANUARY 2011—DECEMBER 2013

To reduce the number of those facing the death penalty, through the commitment of civil society, political and juridical actors and especially lawyers, to improve the defense of prisoners and prison conditions.

Activities of the project:

- ⇒ Awareness activities and workshops on the theme of the death penalty, the trial and fair conditions of detention for civil society organizations, to political and juridical actors, as well as police and prison staff.
- ⇒ Training activities to improve the capacity of the eight intermediary lawyers on the theme of the death penalty, and thus enable them to provide legal assistance to prisoners sentenced to death.
- ⇒ Free legal aid to prisoners incurring the death penalty.
- ⇒ Communication campaigns and advocacy of the death penalty.

Results in 2011:

- Installation mission in March: recruitment of the local project team, including 8 intermediary lawyers (1 by each target state).
- Training mission of intermediary lawyers in July: it brought together lawyers of the Nigerian Bar Association, a partner in the project, lawyers relay operating in the states for the project account and the staff of ASF France to Abuja office - themes: the methodology of the project and arguments against the death penalty.

CAMEROON: Dignity in detention

At the heart of a judiciary system already in difficulties, lack of resources, human resources, culture of compliance of rights, or because of trivialized corruption, the Cameroonian prison environment is in a worrying situation.

According to the figures provided by the State in Cameroon Committee against Torture of the United Nations in March 2010, there would be in Cameroonian prisons, a total of 23,196 inmates, 14,265 defendants waiting judgement to 8931 convicts.

Beyond the prisons, the problem of respect for the dignity and rights of persons deprived of liberty is revealed daily by the worrying situation in police stations where the detained complain about the treatment they receive.

The urgent need for action therefore concerns all venues of deprivation of liberty, to inform detainees of their rights, and sensitize professionals to respect fundamental rights of the detainees to ensure a better compliance.



Cities targeted by the project: Bamenda, Douala, N'Gaoundéré and Yaoundé

DIGNITY IN DETENTION: PROMOTION OF COMPLIANCE WITH THE MINIMUM CHARGE FOR PERSONS DETAINED IN CAMEROONIAN PRISONS — DEC.2010-DEC.2013

Enhance knowledge and respect for rules and minimum guarantees due to the person deprived of liberty

Résults in 2011:

- 195 inmates from the prison of New-Bell in Douala have been legally counseled for free
- 15 cases were selected to receive a juridical follow-up by lawers in Cameroon
- Awareness of the rights of detainees were held by the distribution of posters and flyers

In 2012...

- ⇒ Organise training sessions from different actors of the world prison: prison staff, officers of the juridical police, magistrates, lawyers, grafts
- ⇒ Organise and share information and awareness among people detained on their rights and guarantees.
- ⇒ To provide detainees a free legal aid for their defense and monitor the defense of their case.

LAOS: Training of lawyer students

Despite an action plan for reforming the judiciary system for the period of 2006-2020, the Lao Government lack the financial and human resources to carry this reform.

The Lao Bar Association is the national Insitution in charge of training for lawyers.

In order to strengthen its capacity, it sought to develop additional training (on the use of international legal instruments of human rights protection, the right of defense and the right of a fair trial).

It also considers the establishment of Quality legal services to benefit the Population.

PARTICIPATION IN STRENGTHENING THE PROFESSION OF LAWYERS IN THE LAOS PEOPLE'S DEMOCRATIC REPUBLIC - JANUARY 2010-DECEMBRE 2012

ASF France and the Lao Bar Association have established a collaboration relating to various fields such as:

- * the initial and continuing training of lawyers
- * sharing of experience with foreign legal actors
- * exchange with other judicial actors
- * free access to justice for vulnerable people

- 6 co-trainers and 30 lawyer students trained on "The role of lawyers" as lawyers and international legal instruments

CAMBODIA: The training of lawyer students

In 1998 the Bar Association of Kingdom of Cambodia sought the support of ASF France in the context of the reconstruction of the rule of law.

In fact, four years of Khmer Rouge Regime have decimated the country and bled dry the judicial system.

The Bar of Cambodia, newly created in 1995 faced to the immense requirements of access to justice, to training of its members and to the challenge of the judgement of the former leaders of the Khmer Rouge Regime in the Extraordinary Chambers in the Courts of Cambodian

SUPPORTING THE CAPACITY OF LOCAL ACTORS: TRAINING OF CAMBODIAN LAWYERS AND MAGISTRATES ON HUMAN RIGHTS, RIGHTS OF DEFENSE AND FAIR TRIAL JANUARY 2009-JUNE 2012

- * Strengthen the capacity of lawyers and judges to contribute to a fair trial.
- * Participate in the development of the Center for Lawyers Training and Professional Improvement and of the Royal School for Judges and Procedutors by allowing them to reinforce their initial training and to beneficit of hight quality local trainers.

Results in 2011:

- 55 judge students trained in the "Practice of criminal procedures"
- 60 lawyer students trained to the "Role of the Lawyer" and to the "International Legal Instruments of human right protection"
- 8 co trainers prepared to set up training

CAMBODIA: Legal Aid

To promote better access to justice, ASF France and the Bar Association of Cambodia conducted from 2006 to 2009, a legal aid program which allowed the installation of lawyers in 20 regions of the country, whereas they were previously concentrated in the capital Phnom Penh.

This program was relaunched in January 2010 for a period of 2 years:

22 lawyers deliver free legal assistance to the most vulnerable people in the provinces of Cambodia, providing to population of Cambodia the possibility to see its rights defended in court.

PROGRAM ACCESS TO JUSTICE: LEGAL AID FOR VULNERABLE POPULATIONS JANUARY 2010-JUNE 2012

- * Participate to the promotion of a fair justice and restoration of the Rule of Law
- * Strengthen the legal profession of lawyer and disseminate the rules and principles for the protection of human rights to vulnerable populations in Cambodia
- * Provide access to rights for vulnerable populations in all provionces of Cambodia by providing free legal assistance

Results in 2011:

- 22 Cambodian lawyers present throughout the country deliver quality, free legal assistance to the most vulnerable persons
- 1200 new cases followed (including 972 criminal cases)

In 2012 ...

- ⇒ Lawyers for the program will receive training on "difficulties in implementation of the New Penal Code and the New Code of Criminal Procedure and professional Civil and Criminal liability".
- ⇒ A seminar on the same theme as the one mentioned in the training will bring together different judicial actors (court presidents, judges, prosecutors, clerks, lawyers...)
- ⇒ Continued legal assistance to persons most vulnerable in all provinces of Cambodia

CAMBODIA: The defense of Khmers Rouges victims

To respond to the necessity of legal representation of Khmer Rouge victims, ASF France, in partnership with the Bar Association of Kingdom of Cambodia, created an office to support victims' defense.

A team of Cambodian and international lawyers has been created to ensure the defense of civil parties in front of the Extraordinary Chambers in the Courts of Cambodia.

28 civil parties represented by ASF France on 90 to the first trial, trial of Duch, a former director of the center of detention and torture S 21, who perpetrated the death of more than 12,000 people.

1146 civil parties represented by ASF France on 3867 as part of the trial#2, judging the four former leaders still alive (Khieu Samphan, Nuon Chea, Leng Sary, and Leng Thirith).

The team, acting as volunteers, working alongside other groups of Cambodian and international lawyers order to give the voices of victims, whom, for the first time in front of an international criminal tribunal, have the opportunity to be represented in the trial as civil parties.

DEFENSE OF CIVIL PARTIES IN FRONT OF THE EXTRAORDINARY CHAMBERS IN THE COURTS OF CAMBODIA (ECCC) - MAY 2008-APRIL 2013

Results in 2011:

- 28 civil parties assisted by Cambodian and international lawyers of ASF France in front of the ECCC
- First decision of the conviction and sentencing of Duch (trial #1)
- Preparation of records of victims in trial #2

In 2012 ...

- ⇒ Defense of the civil parties in the appeal trial of Duch
- ⇒ Defense of 1146 civil parties in the trial #2:
 - ♦ Follow up records of the civil parties.
 - Information for victims on the conduct of trials: the team of ASF France encounter victims to inform them of the trial and to discuss the stakes of the trial.
 - Preparation for hearings of victims and witnesses.
 - Participation of counsel at hearings, pleadings.

INTERNATIONAL OBSERVATORY FOR LAWYERS



The International Observatory for Lawyers was created on the initiative of Avocats Sans Frontières France and began its activities in 2008, in partership with the Council of National Bar Associations (France), the Paris Bar association, the Spanish Bar Association and the Italian Bar Association.

SINCE 2008:

- 42 cases of threatened lawyers were followed worldwide
 16 emergency defence missions were organised to protect and support lawyers at risk
- 45.000 euros of financial assistance were distributed

MALI: Respect of the rights of people deprived of liberties



Cities targed by the project lead by ASF France in Mali: Bamako, Kati and Kayes Despite a law in August 24, 2001 establishing the creation of legal aid, no effective system of legal aid exists in the country.

The Malian judiciary system encounters major problems that contribute to the violation of the rights of detained persons.

- * Overcrowded centers of detention
- * Great majority of inmates awaiting trial
- Lack of access by detainees to lawyers and Court records
- Judicial staff are inadequately trained to different rules on criminal procedures and to the minimum guarantees for persons deprived of liberty

PROMOTION OF THE RIGHTS OF INMATES - BAMAKO, KATI AND KAYES 2012-2014

This action is a continuation of a first project of the same nature in the cities of Segou, Sikasso, and Koulikoro.

It seeks to increase knowledge and respect for rules and minimum guarantees for the Detained person in the Malian prison world

Expected results:

- The prison inmates in Bamako, Kati, and Kayes receive free legal advice.
- Around 500 legal actors involved in prisons are trained to the minimum standards gauranteeing the rights of detainees.
- A dialogue is developed beteween the leaders of the judiciary and resolutions are taken to improve prison conditions and the norms of due process while throughout the criminal proceedings.

Activities:

- ⇒ To provide detainees an assistance through legal consultations
- ⇒ Initiate administrative measures for the most urgent cases
- ⇒ Organize training for the staff who work in the prison
- ⇒ Organize round tables for players who work in the prison world

TUNISIA: Strengthening of the institutional capacities of the Superior Insitute of Lawyers (ISPA)

Avocats Sans Frontières France, in consortium with ERAGE (Regional School of Lawyers of the Great Eastern), HEDAC (High School Council of Lawyers) and SOGES SpA (an Italian Company in technical assistance to public and private actors), won a contract from the European Commission to provide technical assistance for the strengthening of institutional capacities of the Higher Institute of the Paris Bar (ISPA) in Tunisia.

This action is situated in the context of improving the judiciary system, strengthening the rule of law and respect for human rights, aiming to propose a new organization of the ISPA in response to the current context of democratic transition and transition to a state of law, and to consolidate its training.



The main expected results are:

- 1. Propose an administrative and financial organization of the ISPA (better management, and independent learning)
- 2. Establish a mechanism for selecting trainers and for the training of trainers (new teaching tools and materials, actions of training)
- 3. Conduct a comprehensive review of the initial training (in orienting more towards training practice)
- 4. Develop an action plan for the development of continuing education for lawyers (needs analysis, formulation of proposals, an action plan)
- 5. Promote the axes of international cooperation of the ISPA with other lawyer training institutes (exchange of best practices, internships abroad)

In addition to its charitable status of international solidarity, ASF France is recognized as a training organization. It trains and prepares its members for intervention under its projects abroad.

These courses are open to practitioners of law and justise around the world.



Training is a priviledged tool for the strengthening and empowerment of local law and practice.

The courses are open to all professionals of the legal and judicial world who want to immerse themselves of the realities of law and justice internationally.

These courses are taught by seasoned professionals, specialized in teaching engineering, and legal practitioners before the International courts.

They use teaching methods adapted to adult education by making them agents of their learning (mixing, simulation exercises, role plays, case practices, ...)

The training of Lawyers Without Borders France is approved by the Bar Council (in France) and can be financed for lawyers practicing in France by FIFPL and is recognized for the continued training of lawyers.
